The General Secretary TGCGTA, Nampally, Hyderabad, in the reference fifth read above, stated that about 400 Junior Lecturers/Librarians /Physical Directors in Junior Colleges, who were drawing State RPS 2015 were promoted as Lecturers/Librarians /Physical Directors in Degree Colleges in the existing vacancies drawing Minimum in the UGC Pay Scales i.e 15600-39100+6000AGP (OR) State Pay Scales of 2015 as per their LPC . Certain Lecturers are willing to continue in the State Pay Scales for their personal reasons, hence requested CCE to issue instructions to exercise option to continue in the State RPS 2015 .

In the circumstances stated above, , and in pursuance of the Government orders in the reference first to fourth read above, the Principals of Government Degree Colleges in the State , are directed to accept the option exercised (as annexed to these proceeding ) in the category of Lecturers/Librarians /Physical Directors of Degree Colleges in State RPS 2015 , and fix their pay in the State RPS 2015 as on the date of promotion as per the F.R 22 (a) i and F.R 22 (b) in the scale of Rs.40270-93780/RPS 2015 , subject to the condition that they have to give an undertaking stating that he/she will not claim UGC Pay Scales 2006 /2016 and future UGC pay scales in the cadre of Lecturer , even if the incumbent is qualified and eligible for the UGC Pay Scales 2006/2016.


